## GENERAL PRICE LIST

These prices are effective as of December 1, 2009 and are subject to change.

The goods and services shown below and following are those we can provide to our customers. You may choose only the items you desire. **However, any funeral arrangements you select will include a charge for our basic services and overhead.** If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

### Basic Services of Funeral Director, Staff, and Overhead

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremation, immediate burials, and forwarding or receiving remains).

Our basic services include; conducting the arrangement conference, planning the funeral, consulting with family and clergy, shelter of remains, preparing and filing of necessary authorizations and permits, coordinating with the cemetery, crematory, or other third parties. In addition, this fee includes a proportionate share of our basic overhead cost. .... \$ 895.00

### Preparation of the Body

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial. (Per Louisiana law, a deceased person must be embalmed, buried or cremated within 30 hours of death).

**Direct Cremation**

(Our charge for direct cremation, without embalming, visitation, or ceremony, includes: Basic services of funeral director and staff, a proportionate share of overhead costs, local removal of decedent, necessary authorization, cremation container and temporary container for cremated remains)..... \$995.00

If you want to arrange a direct cremation, you may use an alternative container. Alternative containers encase the decedent and can be made of materials such as fiberboard or composition materials, with or without an outside covering. The container we provide is a fiberboard container or an unfinished wood box.

**Immediate Burial .....\$ 1,095.00 to \$1,890.00**

(Our charge for immediate burial without embalming, visitation, or ceremony includes: Basic services of funeral director and staff, a proportionate share of overhead costs, document fee for filing necessary paperwork, local removal of decedent from place of death, and local transportation to cemetery. This option shall be at the earliest convenience of the funeral home, within legalities).

- A. Immediate burial with casket provided by purchaser ..... \$ 1,095.00
